AS9100 Rev. D Transition

As you may be aware, the publication of the AS9100:2016 series of standards has been postponed until later this year. The International Aerospace Quality Group (IAQG) has agreed to align transition to the forthcoming revised AS9100:2016 series standards with the International Accreditation Forum's (IAF) Resolution 2013-15, which requires transition to the ISO 9001:2015 quality management system (QMS) standard no later than 15 September 2018. The delay in the standards publication has NOT impacted the transition deadline. It has and will remain September 15, 2018.

This means that PJR will be re-issuing certificates to reflect the expiration date of September 14, 2018. In accordance with IAQG OPMT ICOP Resolution 131, where a certificate is issued or re-issued to an AQMS standard that is prior to 2016 editions, PJR will ensure that the expiration date on the certificate and the OASIS database does not exceed September 15, 2018. Upon successful completion of the transition audit, the certification expiration date will be re-adjusted to reflect the original three-year certification cycle. If transition occurs on a recertification audit, a new certificate with a three-year validity period will be issued.

The AS9100:2016 series of standards will be published concurrently across Americas, Asia-Pacific, and European sectors. The timing of this concurrent release will result in the AS9100:2016 publishing starting in September 2016, 9101 and 9110 in November 2016 and 9120 in December 2016; given a worst case scenario. Efforts are being made to shorten the publication time spans and publish concurrently as soon as possible.

Any company looking to prove that it has implemented and uses best practices, across their organization, would benefit from ISO 20000 Certification. A formal certification will help to drive consistency throughout the marketplace, and shows optimization of operational processes. It can increase the number and complexity of services offered without compromising the quality of services delivered, as well as boosting customer demand within the scope of existing services that are offered.

ISO 9001:2015 Preparing for a Successful Transition

The ISO 9001 standard is the most widely recognized quality management system that can be used in industries of any size and type. The standard is now facing big changes with the most recent update, and organizations will have three years to adapt.

The dynamic nature of the industries that utilize ISO 9001 requires the standard to constantly evolve with them. In addition, a push for consistency and increased comprehensibility within the ISO 9001 standard has resulted in the need for the simplification of language. Lastly, more and more sectors and industries want a simplified approach to multiple certifications, thus requiring improved cross-compatibility between standards.

Key changes to ISO 9001:2015 include an increased emphasis on risk management and involvement of leadership in oversight of the quality management system. Several procedural requirements have been removed; in some cases, they have been replaced with requirements for documented information. Due to the increased role of leadership with the management system, the explicit requirement for a management representative has been removed. An analysis of these changes has shown them to be quite manageable with proper planning and preparation.



Transitioning does not require a complete overhaul of your organization's current system. It is perfectly acceptable to maintain your procedures, quality manual, etc. if they fit your business and how you operate.

PJR recommends some form of transition training for your staff. The level of detail of that training is a decision left to management. It is entirely possible that much of your staff will not be impacted by the company's transition.

Right now, your organization can prepare for a successful transition by:

- Having management fully review the ISO 9001:2015 standard to identify gaps that must be addressed
- Create a plan of implementation with assigned responsibilities
- Update all quality management system documents where changes to the processes have been made.
- Complete transition/awareness training
- Perform a full system internal audit followed by a Management Review Meeting
- Corrective actions for all internal audit findings should be complete or in process
- Coordination with PJR for planning of transition arrangements

Remember, PJR will continue to provide timely updates on the transition process, and will endeavor to enable our clients as smooth a transition as possible. ♦

According to the White House, the Obama Administration is “working to implement a Cybersecurity National Action Plan (CNAP) that takes near-term actions and puts in place a long-term strategy to enhance cybersecurity awareness and protections, protect privacy, maintain public safety as well as economic and national security, and empower Americans to take better control of their digital security”.

Every government agency is now required to identify and prioritize their IT assets based on value and most at-risk, and the Department of Homeland Security is increasing the amount of Federal civilian cyber defense teams to a total of 48, a dramatic increase.

When PJR can start auditing to the new versions of the standards depends on when PJR has transitioned to the new requirements. Considering the above timelines, the transition period for both PJR and its certified clients will be particularly short. PJR will make every possible effort to be able to start auditing to the AS9100:2016 series of standards as soon as PJR completes its own transition to the new requirements and its auditors successfully complete the training. Please recognize that it will take a lot of coordination efforts not only from PJR and its oversight bodies, but also you as a certified organization. Therefore, you are strongly encouraged to review the ISO 9001:2015 to begin your transition activities and be ahead of the game.

Finally, the IAQG Other Party Management Team (OPMT) will be releasing Supplemental Rule SR-003 for transition to all stakeholders in the industry. We expect that SR-003 will mandate additional time to be added for all transition audits, including recertifications. This may potentially mean another audit crunch accompanied by limited auditor resources that was seen industry wide during the transition to the previous versions of standards. Thus, PJR encourages its certified organization to plan ahead and transition successfully in ample time before the transition deadline.

PJR recently had a webinar conducted by Buddy Cressionnie. Buddy is the Americas Aerospace Quality System Committee (AAQSC) chair and Americas leader of Requirements, Projects, and AS9100. He is active in standards development including being a liaison member to ISO/TC 176 WG24 in writing ISO 9001:2015 and US Technical Advisory Group (TAG) where he serves on the US TAG Interpretations Committee. 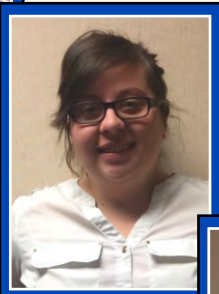
